

Traffic Control Supervisor Refresher

We continue to provide online training via our website at www.indianalaborerstraining.org and while these courses do not replace in-person training they are highly informative. We currently have ten (10) courses available ranging in length from 2 to 8 hours and this has been extremely helpful in keeping the apprentices in training compliance while awaiting their in-person training. We encourage you to visit our website and look at the classes offered.

The Indiana Laborers Joint Apprenticeship and Training Committee accepted 780 New Apprentices into the Construction Craft Laborer Apprenticeship Program in 2021. Including apprentices accepted in previous years, a total of 1,378 remain active. Apprentices participated in 3,397 course completions in 2021 during the summer and winter training sessions. All eleven of the Construction Laborer Local Unions are involved with the Apprenticeship Program providing full statewide implementation of the Apprenticeship Program. The Indiana Laborers' JATC anticipates approximately one hundred fifty (150) Apprentices completing the Apprenticeship Program this year.

We will also provide the "Workzone Traffic Control Supervisor" course again this year. This course is approved by the Indiana Department of Transportation (INDOT). Four (4) courses will be held during the "Winter Upgrade Training Schedule" with two (2) at the Bedford Training Site, Bedford, Indiana for the following weeks: February 21 – 24, 2022 and March 21 – 24, 2022 and two (2) at the Tow Path Ranch Training site in Logansport, Indiana for the following weeks: January 24 – 28, 2022 and February 28 – March 3, 2022. Class size is limited to eight (8) individuals per class and the prerequisite for participants is a minimum of 4,000 Hours of documented road work experience with at least 500 Hours of those being in temporary traffic control.

The Board of Trustees, Indiana Laborers' Training Trust Fund awarded eight scholarships totaling \$ 60,000.00 in July 2021. Seventeen scholarships granted in previous years were also renewed by the Board of Trustees. Since the inception of the Scholarship Award Program in November, 1969 a total of \$ 2,474,971.70 has been awarded to dependent sons and daughters of Laborers affiliated with the LiUNA State of Indiana District Council and to dependent sons and daughters of construction management to help finance their education at various colleges and universities.

I am pleased to report that Alyssa A. Suprenant daughter of Douglas Suprenant a member of LiUNA Local 41, was awarded the annual "Charles R. Morris Achievement Award". In addition, the winner of the "Ralph W. Thrasher Achievement Award" was Gretchen L. Forcum, daughter of Julie Forcum, Office Manager for RTW Refractory, Inc.. These additional monetary awards are presented annually to the scholarship recipients with the highest point total.

The remaining recipients were: Alexandria L. Coleman, daughter of Kendrick Coleman a member of LIUNA Local 120; Joel R. Knox, son of Thane Knox, Division Manager for E & B Paving, Inc.; Callie R. Laws, daughter of Derek Laws a member of LIUNA Local 741; Cruz C. Mitcham, son of Paul Mitcham a member of LIUNA 274; Adam M. Navarro, son of Lorenzo Navarro a member of LIUNA Local 1112; Delaney L. Wilkerson, daughter of Blake Rowe, Jr., Project Executive for Weddle Brothers Construction.

Due to the impact of the COVID-19 Pandemic it was necessary for LiUNA Training & Education Fund to cancel all in person conferences, meetings and certification sessions for the remainder of 2021 this included the Apprenticeship Coordinator Conference (ACC), the Instructor Certification Conference (AIC) and Training Directors Meeting. Although the in-person meetings were canceled, distance learning via Zoom and additional methods allowed for the Instructors to continue with the Credentialing and Certification requirements associated with AIC, ACC, OSHA and environmental refreshers to continue.

Currently the Indiana Laborers' Training Trust Fund has five (5) Instructors who have completed the **ANSI Accredited** "Certified Instructor Program", and five (5) Instructors who are in the process of meeting these requirements to achieve certification. The "Certified Instructor Program" was established by LIUNA Training & Education in 2012 to meet the ANSI-ISO 17024 national requirements for accreditation of our instructional courses. In addition, two of our Instructors have met the qualifications to become a "Master Certified Instructor".

In closing, I would like to take this opportunity on behalf of the Board of Trustees and wish everyone a safe and productive new year with **continued growth** of the **Union Construction Industry.**
